- To present a suitable KPI structure for TRCSL
- To develop an RFP to get the services of a consulting firm or individual for setting KPIs to staff of the TRCSL, and preparation of a plan for implementation

3. Qualifications of Consultant

The Consultant will be selected based on his/her qualifications and experience.

For the purpose of this particular work, applicants should meet the following qualifying criteria as a minimum:

- should possess a degree and a postgraduate qualification in the relevant field.
- should have a detailed knowledge in setting KPIs for achieving the goals of the organization with previous experience
- be fluent in English.

4. Financial Proposal

Applicants are required to submit a detailed financial proposal indicating:

- Professional fees for the consultancy.
- Any other associated costs (if applicable).
