Notes:

- [1]. These packs will be offered to any customer connected through Dialog Fiber, subject to the availability of fiber technology in the area where the customer resides.
- [2]. These are burst bandwidths available on best effort basis for each pack.
- [3]. These packs are subjected to the mentioned GB quota limitations. Once the quota limit is reached, the available bandwidth speed will be limited to 5 Mbps.
- [4]. Voice service will be activated on request for no additional rental. By default, charging will be on per second basis. The customer has the choice to migrate to per minute charging upon request free of charge. The relevant charges are as follows.

Charging Method	Rate Ex. Tax (LKR)

Per Minute	1.50

- [5]. All new connections are subjected to a minimum 02-year commitment period.
- [6]. Rs.5000 will be charged for early termination within the commitment period.
- [7]. The mentioned speed limitations will be applicable once the daily FUP is exceeded.
- [8]. Existing FTTX customers can migrate to the proposed new FTTX plans free of charge.
- [9]. Any mis-users detected in the network will be subjected to be throttled after consulting with TRCSL.
